EDITORIAL

The future of veterinary medicine will turn more and more towards veterinary public health. Our professional responsibility to the society at large is subject of debate in many European countries: animal (zoonotic) disease prevention, development of antibiotic resistance in animal pathogens that have negative health consequences if resistant genes are transferred to human flora, environment hygiene, waste disposal and today in the Netherlands: living in the neighbourhood of large (industrialised) animal farmhouses is very bad for your health.

Politicians, consumers, anxious citizens, animal right groups, welfare and protection organisations all start debating the primary production process of a number of agro products. As soon as the medical profession blames the veterinary sector for their rapidly increasing problem of antibiotic resistance, as a consequence of which patients may die in the hospital the chaotic discussions become complete. Why is there so few of us to join the discussion? Why is there so much distance between what people think and the reality of animal production? Veterinarians serving animal production are scoundrels, and the vet school is a breeding place for even more scoundrels. This may be more so in countries with large exporting agro industry than countries with traditional farming. Industrialised meat production is requesting adapted quality control programming along the production line. (farm to fork principle).

It is obvious that modern veterinary medicine should be able to cope with modern problems in society, even if the problems perceived are irrelevant. Risk perception of the public should also be part of our concern. Public health and human welfare are more important today as compared to the origin of veterinary medicine. In those days in the 18th century it was about food security, transport and tractive power. In the 21st century we in Europe foresee a public that probably accepts to buy food if the producers have fulfilled all secondary wishes in the field of: organic production, animal welfare, environment protection, health promoting products (vitamins, anti oxidants, extra calcium, pre- and probiotics etc. etc.) tasty and preferably affordable. As a consequence veterinarians face different tasks and require adapted education. Both graduate and post-graduate courses in veterinary public health are scrutinised in many places in Europe.

education will meet in Leipzig to discuss the above. The same is true for training our residents in food science as well as in epidemiology. "VPH on the move" was the intriguing title of our annual meeting, last October in Nottwil Switzerland. This very successful meeting both scientifically as from the social point of view may have been a breaking point in our thinking. We will always be on the move, but 21st century thinking and training of veterinarians will rapidly move towards public health in a broad perspective. Will you please consider suggestions for speakers during the Brno meeting in October?

It is good that we are looking forward to the formal EBVS recognition of our College. We have, with great respect to Jeroen Dewulf and Katharina Stärk, renewed our Constitution where it was necessary and sharpened our examinations. This time in 15-16 April we must succeed! We will keep you informed.

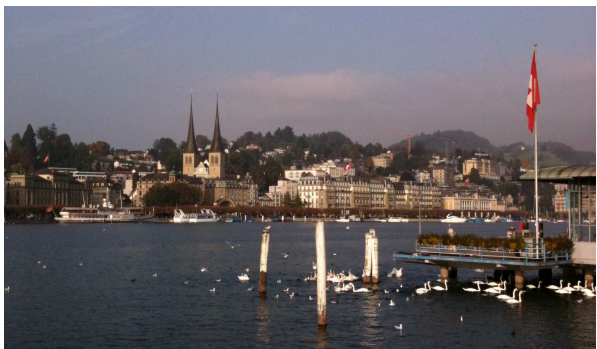

Annual General Meeting and Conference 2010: Nottwil, October 6-8, 2010

The annual meeting of the ECVPH was successfully held from October 6-8, 2010 in the Seminarhotel Sempachersee in Nottwil, Canton Luzern, Switzerland. The conference followed the format adopted in 2007, was organized by the Veterinary Public Health Institute, Vetsuisse Bern, and attracted almost 100 participants.



Within the theme **“VPH on the move – at the interface between human and animal health”**, two plenary presentations (Claudia Stein, WHO Geneva, “Global burden of disease, foodborne diseases and zoonoses”; Peter Deplaces, Vetsuisse Zürich: “Echinococcosis control in Switzerland”), three workshops and three challenge sessions as well as short residency presentations and 32 posters generated a very interesting and diverse scientific content. This was complemented by the friendly but professional atmosphere of the Seminarhotel and its staff, the good food, and the opportunity for continued intellectual exchange in the evenings, at the conference dinner as well as during the excursion to the city of Luzern.



As from participants attending, 55 had returned their feedback opinion form. The Conference received an excellent evaluation as to the venue and organisation and very good/good feedback as to the content and the format.

Educational issues: Residencies and Exam

The education committee has had another busy year:

- between September 2010 and March 2011 we approved 9 new individual residency programs (3 FS and 6 PM) of which one is an alternative residency program (PM).
- At this stage we have a total of 45 approved residency programs and we anticipate to have no less than six residents that will take the exam either in June or October 2011.
- 5 residents have entirely completed their training programs, 3 of them have successfully passed the qualifying exam last year.
- The exam dates for 2011 are 22nd of June and 5th of October 2011. Candidates for the October date

have to apply/submit their credentials until 1st of June 2011 latest!

Diplomates due for re-evaluation in 2011 & compulsory submission of Exam questions

Re-evaluation is compulsory for all Diplomats who received their diploma in 2005 or before. A total of 49 Diplomates are affected. The re-evaluation will be based on the self-declaration of activities during the past 5 years. Activities are classified into six categories and credit points can be collected for specified activities. A total of 100 credit points needs to be reached. The status of Diplomates who do not achieve this target, who do not apply for re-evaluation, or who submit incomplete or delayed files will be set to "non-active". As such, they will still have to pay the annual fees, but will not be allowed to vote, hold office nor use their title as Diplomat. The college reserves the right to intervene against unwarranted use of the specialist Diplomat title.

The deadline for the submission of documents will be **April 1, 2011**. detailed bylaws on the re-evaluation process are available for download on the College website.

In addition concerned members might get alerted, that during the last Annual General Meeting, held in Notwill in Switzerland on October 7th 2010, it was decided that as of this year, Diplomates are **required to submit exam questions before being eligible for re-evaluation**. Each Diplomat is required to submit five multiple choice questions, one short answer question and one problem solving question. Without these, the Diplomat will **NOT** be considered for re-evaluation. Since it is compulsory to submit the re-evaluation form

before the first of April 2011, Diplomates must make sure that the questions that are required to be submitted, are in well before that date. Members concerned are therefore urged to submit **exam questions before the to 1st of April 2011** (extended deadline!)
