REMINDER: Re-evaluation of Diplomates in 2018

In 2018 Re-evaluation is compulsory for all Diplomates who received their diploma in 2002, 2007/2008 and 2013. A total of 19 active (certified) Diplomates are affected. Diplomates being in the "non-practising" (non-certified) membership state need to start their Re-evaluation by initiating the Re-



activation of their membership by a separate request to the ECVPH Council (see [ECVPH e-Newsletter 1/2017!](#))

The re-evaluation will be based on the self-declaration of activities during the past 5 years. Activities are classified into six categories and credit points can be collected for specified activities. A total of 100

credit points needs to be reached. The status of Diplomates who do not achieve this target, who do not apply for re-evaluation, or who submit incomplete or delayed files will be set to "non-practising". As such, they will still have to pay the annual fees, but will not be allowed to vote, hold office nor use their title of Specialist. The **deadline** for the submission of documents is **April 1, 2018**. As additional reminder to all reaccrediting ECVPH Diplomates: as a part of the re-accreditation process, please submit your **exam questions online** via the NEW website. To access the database and use this online-tool for Exam questions at our [new ECVPH website](#) you need to **first login** to access your personal profile.

ONLINE Exam question submission:

Please submit **5 multiple choice** and **2 short answer** and **1 problem solving questions** including model answers. In your model answer, please provide systematic guidance for allocation of marks for standardisation purposes. Accompanying figures, tables, maps or other images associated with the question must be uploaded as a jpeg, png, gif or pdf attachment.

- Vetsuisse Faculties Bern and Zürich and SAFOSO, ("Swiss Consortium"), Switzerland - FS and PM
- Department of Veterinary and Animal Science (IVH), Faculty of Health and Medical Sciences (SUND), Univ. of Copenhagen (UCPH) - PM

Financial Issues - Payment of Fees

As already communicated in our [last e-Newsletter](#), I have taken over business as new Treasurer of the ECVPH at the AGM 2017 in Liège. Online Payment options (see below) of Fees to be paid have been adapted on [ECVPH's Website](#). Let us hereby remind you that with the new treasurer ECVPH's bank account has been moved to the Netherlands and the new bank details are:

Letters invoicing for the yearly payment of the membership fee have been sent recently to Certified and Non-certified Diplomates. The invoice describes how you can pay the required amount and what is necessary for administration purposes so we can link the payment to a diplomate.

Last year we introduced the new website and this will make the payment system hopefully easier and clearer. When you go to the website, log in and open the Pay Fees pages (on top of the screen). There everyone can find "Annual membership fee". You can choose between active/certified and non-certified (the diplomates who have stated that they are in active). When you click on one of the buttons the amount will be added to your shopping cart. Please proceed in this system. You have to decide if you want to pay by bank transfer or electronically (online payment). When you decide to pay by bank transfer use your bank account and make a payment to the bank account of ECVPH (see invoice). Please fill in the name of the diplomate for whom the payment is done. Sometimes the bank account is on the name of the partner or the employing Institute or other and it becomes then very difficult to link the payment to the name of the diplomate. You can also use the order number you received in the process.

Whenever you pay on line by Credit Card or PayPal you will notice that though the relevant amounts of Fees to be paid (see also uploaded [Bylaws on Fees](#)) have not been increased per se, an extra amount of 3,5% is added to the fee due to administrative costs. Using this method you also have to fill in the form which makes it possible to link the payment to the diplomate.

In general for both available **Payment options** you (Diplomates and Residents) may preferably proceed via the [Website](#), LOGIN your personal account, access <https://www.ecvph.org/payments> and select the Fee to be paid:

- the electronic **online payment** option via the College's website can only be completed when it is initiated directly by using your credit card (or via PayPal) for the payment – in that case you will also receive a separate confirmation/receipt after successful completion of the payment!

- If you may select the payment option **by Bank transfer** notice that an electronic payment from our website directly linked to your bank is NOT possible – in that case our website just re-indicates the necessary payment/account details and identifies a Payment order Nr. as a reference for further use (an email containing this order number and indicating the further procedure will be sent to you!). When initiating the payment via your bank account please make sure that your name, the allocated payment order and the reason for payment (i.e. annual fee 2018) are properly indicated in the bank documents/payment order or in the online-banking form. It is important, indeed, that we can univocally identify to whom the payment/s should be allocated (i.e. in case other people or your Institution makes the payment for many members).

Thank you all in advance for your efforts to make the payments as soon as possible with clear info. This will make my work much easier!

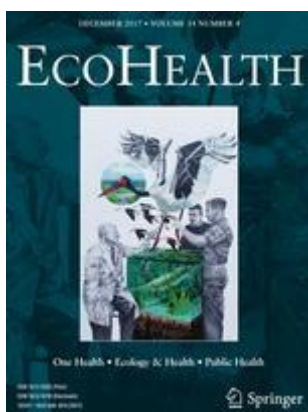

Joint Residency Programme

We are proud to announce that the JRP (joint residents project) has been published!

At the 2014 AGM held in Turin, 16 ECVPH-residents (Laura Falzon, Isabel Lechner, Ilias Chantziaras, Lucie Collineau, Aurélie Courcoul, Maria-Eleni Filippitzi, Riikka Laukkanen-Ninios, Carole Peroz, Jorge Pinto Ferreira, Merel Postma, Pia Prestmo, Clare Phythian, Eleonora Sarno, Gerty Vanantwerpen, Timothée Vergne and Marnie Brennan) got together to work on a new JRP. After a thorough search for an appropriate subject, they agreed to work on a scoping review looking at 'One Health' approaches and ensuring quantitative outcomes. This led to a huge amount of work, including a search through four electronic databases, 42167 papers to review, and many discussions along the way! The work was completed at the end of 2016, and you may now read about the findings through the following link: <https://link.springer.com/article/10.1007%2Fs10393-017-1310-5>.

- year you became a diplomate
- type of residency (if applicable!)
- country where you did your residency training (if applicable!)
